YANKEE Hunt Test 2006

YGRC's Field Committee held our annual AKC Hunting Retriever test on August 19 & 20 at West Thompson Dam and Peakebrook Farm in Putnam CT. Once again, the polished performance of the Field Committee knocked everyone's socks off!

All the credit for this success belongs to the test committee and our volunteers. Chief Marshals Karen Scotti and Jill Moffett recruited terrific, hard-working people from within **YANKEE** and from some of our fellow retriever clubs. If we try to name each person, we run the risk of omitting some wonderful person who helped at our test, so this is a big THANK YOU to everyone who helped!

Donna Morgan, Jonathan Rausch, and Charlie DeMarco (welcome back!) handled on-site equipment transportation. Sheri & Bill Caron and Linda & Jonathan Rausch donned their aprons and fed the masses of hungry workers and handlers at the West Thompson fire station, ably assisted by utility in-fielder Carol White and "grill guy" Phil Erlanger.

Gunners can make or break the success of a hunt test. Thanks go to Ken Lukis, gun captain, for recruiting superior gunners for our test. There were very few "no birds" at our test. We were also glad to welcome our favorite on-site veterinarian, Mike Lappin, who gave up his practice to be at our test. As far as we know, no other club has a vet on site – but then no other club is lucky enough to have Mike. In fact, the Field Committee awarded Mike one of our special jackets to thank him for giving us his time.

The most unsung person at any AKC event is the test secretary. Barb Sawtelle handled our transition into the 21st century, since this year we used Entry Express, an online entry service. Barb also managed all the paperwork for the AKC, as well as the permits for the site and birds, and emergency plan. She also helped with the transportation of equipment to the site, and for the preparation of the marshals' boxes for each stake. Barb is the best! This year's test was dedicated to the memory of **YANKEE** member Jason Nolan. We were delighted to see Jason's mom, longtime **YGRC** member Kathy Berube, at the test. Thanks also go to Glenn Simonson who wrote a lovely dedication to Jason which was included in the hunt test catalogue.

Goldens were well represented among the qualifiers at our test. Anyone who says our dogs are just swamp collies or rugs had better take another look. The results of each stake, including the Goldens who qualified, are on page 8 of this issue.

Bench: Fall Match – Sat., Oct. 14, at Canine Mastery in Seekonk MA, Martha Callaghan, Chair; Donna Cutler will assist. Still need a Spring Match 07 chair & a Specialty 08 chair.

Breeder referral: Several litters listed.

Concessions: Discussed possible items we would like to sell.

Correspondence: Thank-you note and donation received from Monica Land, a judge at our July agility trials. Motion 09-06-01, to send her donation to the *Golden Retriever Foundation* General Fund, passed unanimously.

Field: Memorial for Jason at the hunt test. Hunt Test went well, with a little confusion at the end of the senior test, when one judge left early without explaining his scores. Field Committee requested \$1500 to replace ou aging wingers. Motion 09-06-02, authorizing the Field Committee to purchase five Tangelo Tossers, passed unanimously.

Membership: Membership list distributed electronically to the Board. We are receiving lots of applications for new membership.

National '08: Mini-meetings. Karen Frink will contact people personally.

Newsletter: Has been sent. Next deadline is 10/15/06.

YANKEE Tracking Test

ANKEE GOLDEN RETRIEVER CLUB'S fall TD/TDX Test was held Sunday, September 17, 2006 at High Ridge Wildlife Management Area in Gardner MA. On the morning of the test there was a spectacular display a fire ball of the morning sun over the dew-drenched fields of new growth timothy. This was one time when all the fields were uniform in cover. We had five TD entrants, four Goldens and a German Shepherd Dog.

Track #1: Devin (Elysian's Urban Legend) handled by Noreen Sila. The tracking team was brought to the start flag, and with a little grazing the team headed slowly towards the direction flag found the first corner and then the race to the finish started. All we saw was Noreen's ponytail bobbing along the tracks path until he came to a sit at the article, five minutes after the start.

Track #2: Darka (Darka of Timberridge) a GSD handled by Doreen Metcalf. The harness was fastened, the start command given, and down the hill that tracking team went! She investigated some critter traffic on the first leg, and then negotiated each turn successfully, until a down at the article, again five minutes later.

Track #3: Remi (Northstar N' Pioneer Remembers) handled by Ruth Woodard. The handler obviously showing some signs of anxiety decided to take a moment to reflect. Once ready, this bitch took over the controls and within five minutes showed her owner where the corners werem leading to the glove.

Track #4: Shelby (Mirasol Feta Compli) handled by Amy Deutsch. Another somewhat nervous first time handler, but when started, off they went as if the dog had been given a map beforehand, stopping only momentarily to check out a critter track, finishing and finding the glove in four minutes!

Track #5: Cabot (Northstars Seriously Sharp Huntr RN) handled by Alice Ayers. Once they started, there was some checking at the first, third and forth corners, but he tracked steadily and track sure to the glove in 5 minutes.

All these dogs were fun to observe in the field. Even though the tracks were trenches the dogs all tracked successfully to the end article in record time. For some of these handlers it was their first time entering a test and their first tracking title. The TDX is the next test to be mastered, and I am sure each dog we tested today is capable of earning it.

The TDX draw was at 10 am, and by that time the sun had started to dry out the heavy mornings dew.

Track #1: This dog was led to the start flag and without hesitation he headed down the first leg and negotiated the first corner. The track went into the woods and the dog started in but wanted to come out into the field. He then turned himself around and reentered the hedge row, finding article #2. He proceeded out of the hedge row into a large open field with an open turn where he investigated the first set of cross tracks, returned to the track, made the next turn and completely ignored the second set of cross tracks. The next turn headed into the woods, and this time he entered them without hesitation and located article #3. Once out of the woods he experienced some difficulty orientating himself as the turn was right at the exit point. Once this problem was solved he headed for a road where there were three loose dogs in the distance which interrupted his concentration. But he returned to the track where the final leg headed uphill. He had to deal with several cross tracks from earlier that morning where someone was playing Frisbee with their dog, but sorted this situation out and went onto the glove to much joy and adulation of his handler. I judged the dog this spring and he went right over the first corner, but today he finished the track in 15 minutes. This was my first titling Australian Cattle Dog, Anzac, ably handled by Anne Albright Smith.

Track #2: Duke, a Spinone Italiano handled by Jacqueline Carey, cautiously approached the start flag, started to graze and did not appear to understand why he was there until he was about 25 feet beyond the start flag. He got to the first corner and started to experience more difficulty until he found the first set of cross tracks and wanted to follow them. Once reoriented he made the second corner and with no hesitation entered some tall vegetation. However the second set of cross tracks were too inviting and when he followed the cross-tracklayer out of the field the whistle was blown.

Track #3: A Golden Retriever handled by Alice Ayers, approached their track without a start flag that must have been removed by some walkers, however, the start article was still in place. The dog easily found the start article, had some difficulty part way down the track with either critter or human cross tracks, made the first corner after which they encountered the first set of cross tracks. Unfortunately the dog locked onto the cross tracks and the whistle was blown.

We had a successful day as the weather, field conditions and dogs provided all that is necessary for this type of test. I would like to thank YGRC and my co-judges Randie Meyer and Ray Desmarais for making this day the success it was. We cannot forget the track layers who play such a vital part in the feasibility of the test. Thanks also to our Chief Tracklayer, Paula Orcutt, for organizing the track layers and being there when we all needed her, to Test Secretary Kathy Goodman and Test Chair Marsha Wilcox for all their efforts, and to our hostess, Carolyn Zagami, for a delicious luncheon.

Things are moving along on the planning for the 2008 GRCA National. We are working with a graphic artist to create a logo and should have a rough draft by the end of October. Requests for proposals have been sent to four show superintendents, with responses also expected by the end of October. The contract has been signed with the host hotel, and other contracts are being finalized with the overflow hotels. A fundraiser is underway. Pagey Elliott has designed one of her famous puzzles for us from a print donated by Marcia Schlehr. Joy Viola has graciously volunteered to sell tickets for the puzzle. Joy took the tickets to Goldstock this year and to this year's GRCA National. You can catch a look at the puzzle on page 12 and on the **YANKEE** Web site. Next steps: We need to finalize the logo and begin the selection of merchandise for sale. We have to select the judges; sign a contract with a show superintendent, and search for trophies.

- *Rosettes* We need a conscientious person to coordinate and order the rosettes for each event, with input from the various chairs/committee members.

GRCA Delegate Report

he following resolutions, approved by the GRCA's Board of Directors, are for the information of **YANKEE** members and require no action.

<u>06-45</u>. Authorizing reimbursement to Rhonda Hovan for airfare to attend the AKC Canine Health Foundation Genes, Dogs and Cancer Conference, with an article to be published in the *Golden Retriever News* describing this conference no later than six months after the conference is held.

<u>06-46</u>. Authorizing the GRCA Archivist to purchase an Epson Perfection 4490 flatbed scanner for the copying and digital preservation of archival material.

<u>06-47</u>. Amending Section 2. RECIPIENT ELIGIBILITY of the GRCA Trophy Regulations by adding the following: *g. Residency. The Trophies must reside in the United States or Canada.* Amending Section 8. From Ron Menaker, Chairman of the AKC Board and Dennis B. Sprung, President and CEO: At the September Delegates Meeting, AKC reported that we had reached an agreement with Petland in order to facilitate the registration of dogs that are already AKC registrable. AKC's Board of Directors and management believed that this agreement would have helped to further the mission of the AKC. Promoting responsible dog ownership to new puppy owners, implementing our care and conditions policies, and exposing more dog owners to AKC educational programs and services would have had even greater reach. In the past few weeks we have received many

comments about this agreement, both positive and negative. We have listened to the concerns and because this issue has become so divisive, we believe it is in the best interest of our sport and the AKC not to go forward with this initiative.

Poison Control Hotline — 24-hours, free


Kansas State University Veterinary Teaching Hospital offers a *free* 24 hour poison control hotline for pet owners and veterinarians:

785 532-5679

Dr. Oehme, a vet and professor in toxicology and pathology, oversees the hotline and offers these suggestions:

- When calling, be patient the person answering the phone may have to take a few minutes to consult the vet on duty.
- If you suspect poisoning, call as soon as possible! Immediate attention may save your dog. Waiting to see if there is a reaction could cost your dog's life.
- Have any product labels available. The vet might need to know milligrams and generic names.
- Know your dog. Not all "symptoms" indicate poisoning. Drooling could mean he's just thrilled to see you!
- Bear in mind that the toxicologists are also taking calls from vets about other animals and other problems.

YANKEE Breeder Referral Breeder Referral Listing & Newsletter Listing Policy

ANKEE GOLDEN RETRIEVER **CLUB** offers the Breeder Referral as a service to member breeders, stud dog owners, and prospective puppy owners. Acceptance of a listing does not guarantee placement of puppies, and does not constitute endorsement by the club or any of its members. Neither the club nor its Board of Directors assumes responsibility for the quality, health, soundness, or temperament of any litters listed. YANKEE recommends that a fully executed, written purchase agreement setting forth all the terms of purchase be obtained before possession of a puppy is transferred to a purchaser. YGRC members may list litters, older puppies, and adult dogs with the Breeder Referral Listing and in Finish Lines if the breeder/stud dog owner has been a member of YGRC or another GRCA-member club for a minimum of one year, and submits the following:

• Copies of AKC registration certificates, thereby verifying that both the sire and dam were over 2 years old at the time of breeding.

• Eye clearances on both the sire and dam, issued by a veterinary ophthalmologist who is certified by the American College of Veterinary Ophthalmologists. Clearances must be current during the time the litter is listed. Eye clearances on dogs under 8 years of age are valid only for one year from the date of issue. CERF certificates will be accepted.

• Hip clearances on both the sire and dam. Dogs must have final OFA Certification or PennHip Distraction Indexes below the median done at or after 6 months of age, with no radiographic evidence of hip dysplasia.

• Final heart clearances on both the sire and dam, issued by a veterinary cardiologist who is certified by the ACVIM (Cardiology).

• A *Litter Listing Agreement*, completed and signed for each litter listed.

AII listings and copies of clearances should be sent to the **YANKEE** Breeder Referral chair listed on the back page of this newsletter. Referral listings will run for 10 weeks; please contact the Breeder Referral chair to pull or to extend the listing. The listing fee is \$30 per calendar year or \$5 per older puppy or adult. Litters listed with the Breeder Referral service are automatically listed in the newsletter. Please note: **YGRC** members who own stud dogs may list letters sired by their dog when the breeder is not a **YGRC** member, provided the same listing criteria have been met by both sire and dam.

"No spring nor summer beauty hath such grace/ As I have seen in one autumnal face," wrote John Donne. I don't want to be a worrywort, but it's time to give y'all another cautionary reminder. Fall is hunting season, or it will be soon, in various parts of New England — turkey, upland birds, deer. Every year, it seems, some persons or dogs are injured (or worse) in hunting accidents. So if you're going for any autumnal woods walks with your dogs, please be careful. Before you head out, check your local hunting regulations and start times. Try to avoid known hunting areas. Usually, the local, county, and state fish & wildlife departments have maps and other guidelines. When you and your dog do head out for a stroll, try to stay in open fields where you'll be clearly visible. If you run into any hunters, tell them what your planned route will be. Wear a safety orange vest. Sporting goods stores sell ones that are very lightweight and can go over your jacket or sweater. *Don't* wear a white scarf or hat! By the way, some pet supply stores also sell doggy scarves in safety orange with Velcro closures, so they're pretty easy to slip onto your dog. Carry a whistle so you can sound the alarm. And of course, if your dog doesn't have a dead-solid-perfect, 110% fail-safe recall, keep him on leash!

And now a plea. There are several dog events coming up over the next several months, run by **YANKEE** and by other clubs – bench shows, obedience and rally trials, agility trials, show & go matches, rescue fundraisers. Please volunteer and pitch in. Our dogs give us so much, we really need to give back a little to the sport of dogs and to each other.
